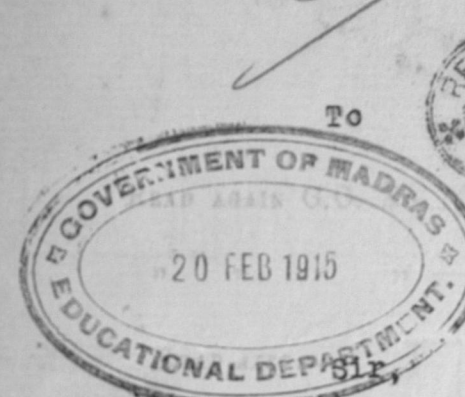

From the I am directed to acknowledge the receipt of your letter No. 1434-Mis., dated the 16th December 1914, on the subject of the remission of charges on account of establishment and tools and plant on works carried out by the Military Works Services from the grant of Rs. 45,000/- sanctioned by the Government of India, Education Department, towards the cost of certain additions and alterations to the Lawrence Memorial School buildings at Ootacamund.

2. In reply, I am to state that no departmental charges are levied by the Military Works Services on buildings classed as Imperial Military buildings. As the Lawrence Memorial School buildings come under this category, no contribution charges will be required to be paid in connection with the additions to the School buildings.
