I have the honor to state that a sum of Rs. 9000/- was sanctioned in G.O. No. 258 Misc., Edl., dated 6-3-1915 for the construction of a building for the Municipal Gosha Girls' School at Negapatam. The Gosha Girls' School at Nagore has grown considerably in strength - the number of pupils being 100/- and there is no suitable building to accommodate the school. The Council has therefore resolved to utilise the sum of Rs. 9000/- given for the Negapatam school towards the construction of a building for the Nagore School. Copy of the Council's resolution sanctioning the utilisation is Enc. 1.

[With reference to your correspondence ending with your R.C.No. 298 of 1915 dated 23rd September 1915, I have the honor to make the following proposals regarding the ~~xxxx~~ strengthening of the teaching staff in the two Mohammedan Girls' Schools in the Municipality and to request that you will be good enough to obtain the Government sanction for the same at an early date.

Municipal Mohammedan Girls' School, Nagore.

Municipal Mohammedan Girls' School, Negapatam.

The minimum pay of the teachers is fixed at Rs. 15. on account of paucity of trained Mohammedan Mistresses.]

(A) Further it is seen from the G.O.No.258 Mis. Edl. dated 6th March 1915 that a subsidy of Rs.9000/- was sanctioned for the construction of a building for the Negapatam School. As the Negapatam ^{School} is held in a building free of ~~xx~~ rent (vide your letter R.C.No.46/14 dated 2nd May 1914) and as I am opinion that the Nagore School is in urgent need of a building of its own on account of its growing strength, I request that Government may be addressed to transfer this amount to the erection of a building for the Nagore School, if a building for the Negapatam School is not yet begun.

The indent for books and furniture for both the Schools has been called for and will be forwarded to you on receipt.

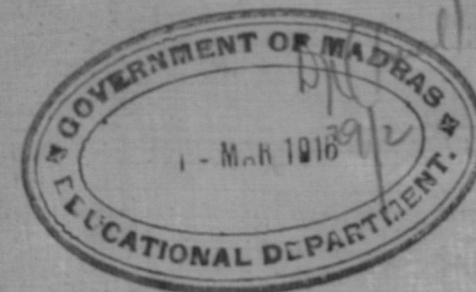
