(1) In G.O.No.890 Edl.Mis dated 28th July 1914, H.Krisnan
Naidu, District Board Head Clerk was permitted to appear
for the Criminal Judicial Test, Lower grade. He failed
in the Examination as he has had not sufficient time
before the examination to prepare for it in 1914 and last
year on account of the severe epidemic of fever that pre-
vailed in Bellary from September he could not prepare for
the examination as he was suffering from fever.

2. He has passed the Upper Secondary examination and
was eligible to appear for the 2nd grade Pleadership exa-
mination which has been abolished. He has lost an appor-
tunity of qualifying himself for posts requiring the
Criminal Judicial Test. I have the honour to request
that the Government may be pleased to permit him to appear

for the Criminal Judicial Test, Lower grade for another two years. As the number of chances exceeds ~~three~~ application is made to Government.

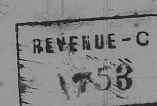
