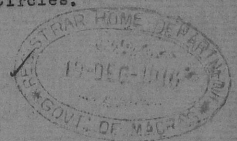

Modification of Grants.

J.S.

With reference to telegram No. 2727 B, dated 14th November 1916, the E.E. West Coast Division applied for additional grants under 45 Provincial. The only item which calls for remarks is "Constg: an additional building and hostel for the Victoria College, Palghat". The E.E. applies for a grant of Rs. 3,100 for completing the work in the current year. As the building, after completion, will remain the property of the Municipal Council, the allotment for the work will have to be sanctioned by the Educational Department from the grant provided under "22 Education" for "Hostels". Educational may be requested to allot the amount.

2. The proposals in this file result in a net additional allotment of Rs. 2,256. Financial have agreed to sanction a ~~total~~ total grant of Rs. 1.68 lakhs to meet the demands of other E.E.s. They may be requested to sanction this demand also.

A draft order on the case is submitted which may be sent to Home (Educational) and Financial for acceptance.
