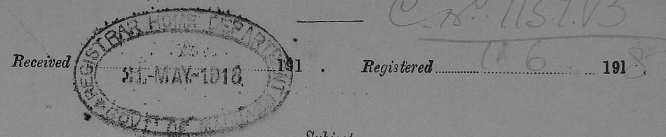

" I have the honour to report that the Rs2,000/- sanctioned in G.O.No.1106 Educational dated 11th December 1912 for covered playground for Kindergarten Department has been so far unspent, owing to the difficulty of finding a site where a covered playground could be erected for this sum.

2. The sum of Rs150/- has been spent in improving a playground for the Kindergarten - but as the Kindergarten are now to be housed in a separate building, the Committee proposed to spend the remaining Rs1,850/- in the provision of two fives courts for the boys and have asked the Assis-
