Sir,

I have the honour to state that Government have, in their order No. 1677 (Home) Edl., dated 27th December 1918, been pleased to sanction a subsidy of Rs. 4,000 to this Municipality for the construction of a building to the Municipal Muhammadan Elementary School, Saidapet. The Council had applied to the Director of Public Instruction for a grant of Rs. 30,000. One of the items comprised in this application was for a sum of Rs. 4,000 for incomplete works of the Municipal Elementary School building, Saidapet. The construction of this building was undertaken with the help of the provincial grant sanctioned in previous years and the following items of work yet remain to be completed thereto:-

(i) Additional accommodation to meet the growing --

demands of the institution and for keeping furniture and other articles.

(ii) Provision of latrines,

(iii) Compound wall round the building without which the safety of the building cannot be ensured.

& (iv) Removal of a few insanitary dwellings in front of the building.

2. The Assistant Inspector of Schools has remarked that these improvements are urgently necessary and has concurred in my proposal to utilize the grant of Rs. 4,000 now sanctioned in the G.O. under reference for this purpose. I request that you will be good enough to permit me to utilize the grant in the manner above stated. A copy of the resolution of the Council is enclosed.
