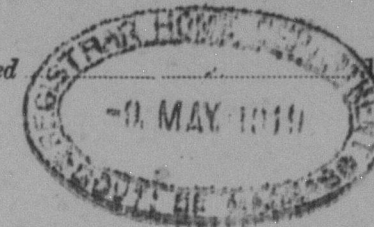

Copy of letter No.1961, dated 15th April 1919, from the District Judge, Godavari, to the Registrar, High Court, Madras.

In forwarding herewith for submission to Government the application of K. Viraswamy, 3rd grade amin, Temporary District Munsif's Court of Ramachandrapur, praying to be exempted from the examination rules in respects of posts carrying a salary of upto Rs.25/- per mensem, I have the honour to state that the District Munsif of Ramachandrapur strongly recommends the applicant for the exemption prayed for by him saying that "he is an intelligent amin who knows his work well and does it satisfactorily". But I cannot support the District Munsif's recommendation as the applicant has no special claim for exemption and as his antecedents are bad, he having been suspended once before for 6 months for making a false return when he was a process-peon.

Most Honoured Sir,

I humbly beg to submit that I am 3rd grade Amin in the Temporary District Munsif's Court of Ramachandrapuram. I put in nearly 27 years hard service in this department. I further beg to state that I underwent Survey Training and obtained a certificate of success. I have been discharging my duties to the entire satisfaction of my superiors.

I belong to a respectable (non-brahmin) Telaga family with a big family depending on me. Since the pay of the 1st grade amin is now raised to Rs. 25 I hope to be raised to a 1st grade amin's post even by the time I may be permitted to retire, so that I may have the satisfaction of retiring on Rs. 25/-. Now according to the Public service notification - unpassed candidates cannot get posts carrying a salary of Rs. 25/-. I respectfully beg to submit that I may be exempted from examination rules to hold a post carrying a salary of Rs. 25/-.
