I have the honour to state that under Government Order No.757 Home Department dated 11th June 18 a Middle School was opened at Challapalli on 1st July 18 with the aid of Provincial funds and it was taken under the management of this Taluk Board. The establishment attached to the school applied for the payment of war allowance at the rates sanctioned to the Government servants with retrospective effect. The Taluk Board in its Resolution nos.386 dated 29-3-19 and 44 dated 22-5-19 (copies enclosed) sanctioned the same with effect from 1st July 18 with the remark that it would be paid on receipt of funds from the Government.

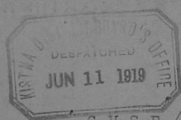
