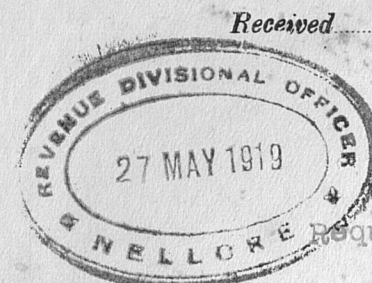

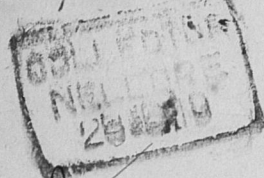

With reference to your letter No. 256 dated the 8th April 1919, the grant of Rs. 5000/- sanctioned to the Nellore Municipality in G.O.No. 304 Home (Judicial) dated the 12th March 1919 and authorised for payment in this office letter No. T.M. 27-24866 dated 21-3-19 should not be paid during the current year (1919-1920) without fresh sanction of Government as the allotments made in the G.O.were out of the grants provided in the Budget Estimate for 1918-19 and these grants have lapsed on 31st March 1919 and cannot be drawn against in 1919-20.

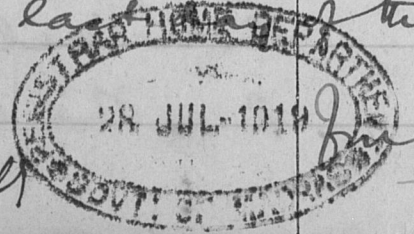
