According to the change in the number of scholarships
sanctioned in G.O.No. 736, Home, Education, dated 24th June 20 one
final scholarship for men and one for women can be awarded under

years or to one studying in the third year class of the B.A.

women's scholarship. The scholarship for men was awarded to
B.H. Mulley who is reading in the third year class of the B.A.

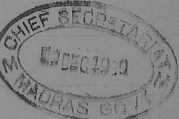
