I have the honour to acknowledge with sincere thanks the receipt of G.O. No.877, Law (Education) Department, dated 9th June 1921.

2. The Committee regret that the Principal made a slight clerical error in submitting the report. The intention of the Committee was to treat the Headmistress, Girls' Branch and the Headmistress (Preparatory Branch) on the same footing as regards increments and to place Headmistress (Preparatory Branch) on Rs. 300 - 10 - 250/- p.m.

By a clerical error, the salary of the Headmistress (Preparatory Branch) was submitted as 200 - 5 - 250

I am to request that Government may be pleased to kindly sanction the change of 5 into 10 for this post.

It will be seen that in their letter
of 27.8.20 (p. 8 of letter No. 1394 of
29.11.20) the ^{committee} ~~revised~~ proposed
Rs 200 - 5 - 250 (average cost ^{Rs} 230 ⁵/₉)
as the revised pay of the Head-
mistress, Preparatory Branch, and
the same ^{scale} is repeated in their
letter on p. 4 of G.O. 877 of 9.6.21.
This figure has also been
reported to India - p. 18 of letter
No. 1394 of 29.11.20 - and is the
one sanctioned in G.O. 877 of
9.6.21.

report that their intention is
to treat the Headmistress, girls'
Branch and the Headmistress,
Preparatory Branch on the same
footing

footing as regards increments and therefore recommend the pay of the ladies to be altered to Rs. 200-10-250. With regard to this argument it may be pointed out that the committee's proposals regarding the revised scales of pay of the staff are based on those obtaining at Sanawar; and ^{as} that the two corresponding Headmistresses there are ^x not on

the same footing as regards increments, it is for consideration whether the committee's present proposal will be accepted.

3. The average extra cost caused by the change comes to $\frac{1}{2} (233\frac{5}{8} - 230\frac{5}{9})$ 27 p.m or about Rs. 33 p.a. If accepted, it will have to be reported to the Govt. of India; also Rs. 577 & 9.6.21 will have to be modified in regard to the scale as well as to the temporary pay^x of the present incumbent of the post for 1921-22.

The pay of the Head Mistress of the Girls' Branch is Rs.250--10--350/-, a scale which takes 10 years to reach the maximum. The original scale proposed for the Head Mistress of the Preparatory Branch was Rs.200--5--250/-, which similarly takes 10 years to reach the maximum. I see no necessity for the change suggested now and reported to be due to clerical error. It is more equitable to have the time, which is occupied in going from the minimum to the maximum pay, the same in the case of the Head Mistress of the Preparatory Branch, as it is in the case of the Head Mistress of the Girls' Branch.
