Sir,

I have the honour to submit herewith a copy of letter R.O.No.38 G.O. of 1921 dated 22nd May 1921 received from the Chairman, Municipal Council, Tiruvannamalai, and to state as --- follows:-

In the statement showing the progress of expenditure for 1919-20 forwarded to this office with reference to G.O. No.415 L dated 1st May 1920, the council, by mistake, seems to have entered the sum of Rs.492/ in the balance column and so it was treated as unspent balance on 31st March 1920.

In the circumstances stated by the Chairman, it is --- recommended, that a sum of Rs.139/ may be paid to the municipality. The expenditure can be met from the Budget provision for Municipal Secondary Schools for 1921-22 under "31B(b)

111-Education-Secondary-Grants to Local Bodies for Secondary Education".

If the above proposal is accepted the Accountant-General may be requested to place the amount at the disposal of the council.
