Sir,

With reference to G.O. No. 565, Educational, dated 14th the June 1913, I have the honour, by direction of the Syndicate, to request the approval of His Excellency the Governor in Council to the appointment of Professor W. A. Craigie, M.A., LL.D., of the Oxford University as a Special University Lecturer for the academic year 1921-22.

The Syndicate has, on the recommendation of the Board of Studies in English, decided to take advantage of the proposed visit of Professor Craigie to Madras about the end of this year by inviting him to deliver a short course of special University Lectures in any subject he may choose subject to the final approval of the Syndicate. The lectures are to be delivered at the end of the year, the cost thereof being defrayed from the annual Recurring Grant of Rs 65,000 from the Government of India. I am to add that the Syndicate has obtained the sanction of the Senate for the proposed lectures at its meeting held on the 4th March 1921.

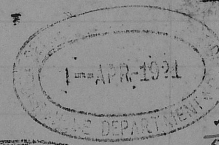
