SIR,

I have the honour to bring to your notice the question of the acting allowance to Messrs W.C. Old and T.K. Manumantha Rao which has come under consideration in dealing with the recent re-organisation of the Indian Educational Service. These two officers are members of the Provincial Educational Service and have been acting in the Indian Educational Service although they are holding the posts of Instructor in surveying and drawing, College of Engineering and Lecturer, Kumbakonam College, respectively, which have not been included in the cadre of the Indian Educational Service. This practice of permitting officers to draw acting allowance for acting in the Indian Educational Service even though they are actually doing the duties of posts outside the Indian Education Service cadre has been hitherto allowed on the strength of the Government of India letter No. 824 Education dated 19th March 1920.
