As the sanction accorded in G.O. No. 651 Home (Education) dated 2nd June 1920, to the retention for another year from the 1st March 1920 of the temporary English tutor on Rs. 100 per mensem attached to the hostels of the Government Secondary and Training School, Triplicane, expired on the 28th February 1921, I have the honour to request that Government may be pleased to sanction the continuance of the post for a further period of one year from the 1st March 1921.

2: There are now 18 girls - 9 Brahmans, 8 non-Brahmans and

and one Indian Christian - attending the special English class.

3. Provision for the salary of the tutor has been included in the Budget Estimate for 1921-22.

4. As the application for the continuance of the post was received from the Circle Inspectress only at the beginning of this month, I regret I could not submit the application earlier.

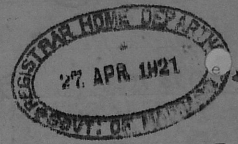

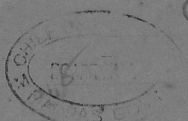

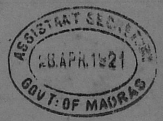
