(W) In Government Order No. Mis. 283 Revenue, dated 3rd
February 1920, M.R.Ry. P.S. Ramanjulu Nayudu, was appointed as
an Appraiser on Rs 200-10-350, on probation in the Madras Custom
House. Government were also pleased to exempt him temporarily
from the examination rules for a period of three months - vide
(S) Government Order No. R 48 Home (Education) dated 7th February

1920.

1920. At the instance of the Collector of Customs, Madras, the Board extended the temporary exemption for a further period of nine months. The Collector now recommends the Appraiser's permanent exemption from the examination rules so that he may be confirmed when opportunity offers. The Board accepts the Collector's recommendation and requests that Government may be pleased to exempt M.R.Ry. P.S.Ramanjulu Nayudu permanently from Article I of the Public Service Notification.

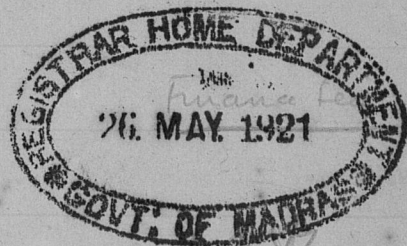
