in Proceedings of the P.W.D. No. Mis., 236 W., dated 16th

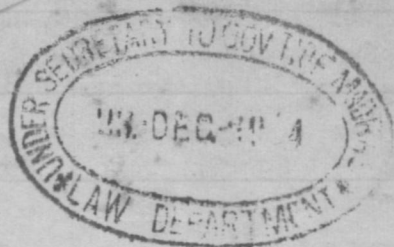
February 1921 communicated with endorsement of the Home (Edu

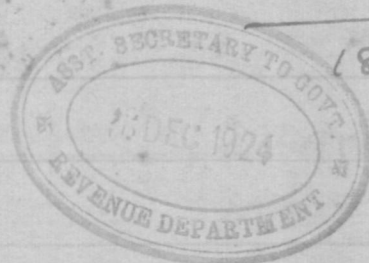
