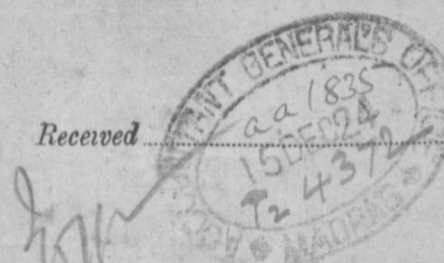

Sir,

With reference to G.O.No. 916 Law (Education) dated 5th June 1924, I have the honour to state that the statistics connected with the intensive survey of rural areas ordered therein are being received in my office and a proper and detailed scrutiny of these statistics is very necessary before they are accepted on the basis for the further expansion of Elementary Education in this Presidency. This work cannot however be undertaken by the present establishment in my office.

I therefore request that Government will be pleased to sanction, for the purpose, the deputation for 2 months from after Christmas of an officer of the grade of Deputy Inspector of Schools and to grant him a pay of Rs.250 per mensem as was sanctioned in G.O.No. 290 Mis., Law (Education), dated 22nd February 1924, when the experimental survey of Saidapet Taluk was undertaken.

2. The cost ~~est~~ during the current year will amount to Rs.500 and the necessary reappropriation statement for meeting this is herewith enclosed.

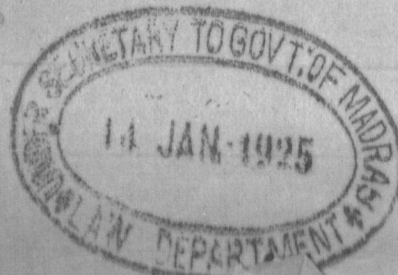
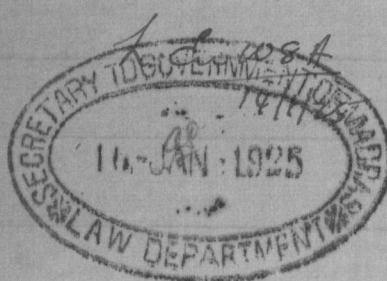
