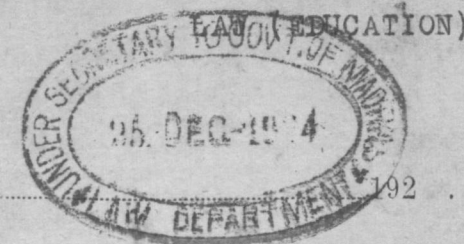

In their order No.1767 Mis., Law (Education) dated 20-12-23, Government approved the Director's proposal to attach a weaving class to the Municipal Elementary School for Sourastras, Walajapet and sanctioned the payment to the Municipal Council of a subsidy of Rs.790 (Rs.700 for tools and Rs.90 for recurring charges for 2 months) during 1923-24.

2. The Chairman, Municipal Council, Walajapet, now reports that the class was not opened within the year 1923-24 owing to the delay in procuring looms and other materials.

3. The class is reported to have been working since 3-8-24 with 15 pupils from Standards III & IV. Each pupil is receiving 10 periods of instruction per week.

4. Out of the subsidy of Rs.790 sanctioned last year, a sum of Rs.390 only was spent during 1923-24 towards the purchase of weaving appliances so that the Council has still an unspent balance of Rs.400 to its credit at the beginning of the current year.

5. The estimated expenditure of the class according to the revised statement furnished by the Chairman, a copy of which is herein enclosed, comes to Rs.730 of which Rs.310 is non-recurring and Rs.420 recurring.

6. In view of the fact that a sum of Rs.310 under initial cost was allowed to lapse during 1923-24, I recommend that the amount of Rs.310 asked for by the Council under non-recurring charges for the current year be allowed.

7. As regards recurring charges, the full amount of Rs.420 will have to be taken into account as the class has been started only on 3-8-24.

Thus the total subsidy payable to the Council during the current year will be Rs.730/-.

8. As however the Council has an unspent balance of Rs.400/- as already referred to, the net amount of subsidy payable to the Municipality for the weaving class will be Rs.330 which I recommend, may be met from the provision of Rs.6400 under "31.C(b)(iii)-Education-Primary-Transferred-Grants to Local Bodies for Primary Education-Grants towards the cost of Vocational and pre-vocational training" in the Budget Estimate for 1924-25.

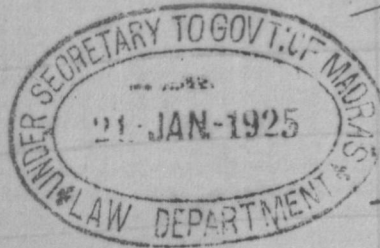

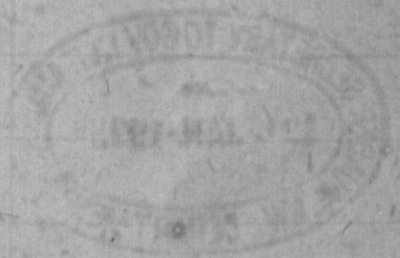
