Reference is solicited to paragraph 3 on page 2
and to paragraph 3 on page 4 of the notes to G.O. No.
881 Law (Edn) dated 25-7-22. ^{Primary} ~~Elementary~~ departments
of secondary schools are recognised by the Director of
Public Instruction and not by ~~the~~ District Educational
Council. So, fees need not be abolished in such schools
on the introduction of compulsory elementary education
and no compensation is in ~~contemplation~~ consequence
payable. The Inspector of Municipal Councils may be
informed that ~~may~~ a reply may be sent to the Chairman,
Municipal Council, Coimbatore, as suggested.

2. It does not appear ^{desirable} at this stage to issue a
general order on the subject, especially as the question
of amending the Elementary Education Act is under
consideration.
