2. In the subsequent two years the lists were not
printed for want of sufficient funds and consequently
they could not be supplied completely even to the
Educational Officers in the District.

2. Since the Educational Officers require a complete list for their guidance at least this year in the revised form, I have the honour to request you to be so good as to sanction a sum of Rs.300/- for the purpose so that necessary copies may be printed and supplied to all the officers in the District and to the Director of Public Instruction.
