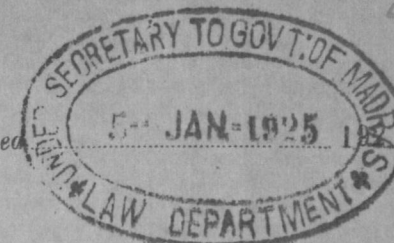

Sir, Through the Director of Public Instruction, Madras & The District Educational Officer, Ganjam.

I have the honour to state that games fees are levied at present in all the Board High and Middle Schools except in the Middle Schools at Surada, Buguda and Sompeta. The latter 3 Middle Schools are not provided with play grounds and hence no games fees are levied in them.

The average annual income on account of games fees during the last 3 years amounted to Rs.661-10-4 in the case of the 4 High Schools and Rs.71-14-2 in the case of the 3 middle school.

I request that Government may be pleased to permit me to include the cost of games, not exceeding the amount collected from the boys in the previous year, in the net cost statement.

2. The total expenditure for games during 1923-24 in the schools under the Ganjam District Board is reported to be Rs.470-9-0, whereas the receipts on account of games fees amounted to Rs.779. Therefore, the games in schools have not suffered for want of funds.

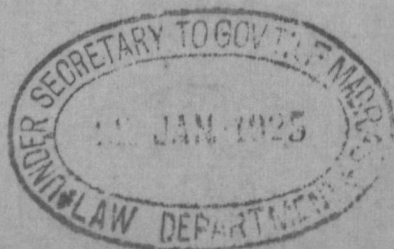
