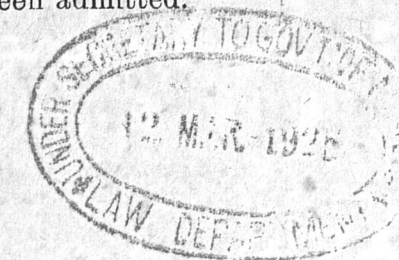

A. (a) Yes.

(b). A copy of the letter, dated 3rd February 1925, from the District Educational Officer, Malabar, is laid on the Council table".

Mr. R. Veerian : - "Sir, with reference to the answer to clause (b) the Educational Officer himself says in his report that admission is denied to the depressed classes. In such a case may I know whether Government have asked the Palghat Municipal Council why they should locate the school in the middle of the Agraharam?

The hon. Rao Bahadur Sir. A.P. Patro :- It is engaging the attention of the officers.

Mr. R. Veerian : - May I know whether Government have given any grants to that school?

The hon. Rao Bahadur Sir. A.P. Patro :- "The question, as I said, is being enquired into by the officers".

The L.C. Question was answered as given above. with reference to the portion marked A it is submitted that the Chairman, Municipal Council, Palghat has submitted a proposal to amalgamate the school with the middle school.
