The audit of the accounts for the 1st half year was commenced on 15th February 1924 and ended on 22nd February 1924 and ~~that~~ for the 2nd half year ~~was~~ commenced on 1st September 1924 and ended on 8th September 1924.

2. During the period under audit, the office of Chairman was held by M.R.Ry.A.Setturama Mudaliyar Avargal up to 2nd December 1923 and from 18th December 1923 to 10th February 1924, by M.R.Ry.K. Maswami Pillai Avargal, Vice-Chairman from 3rd December 1923 to 17th December 1923 and 11th February 1924 to 17th February 1924 and M.R.Ry.S.Muthuswami Mudaliyar Avargal, B.A., B.L. from 18th February 1924.

3. A statement of receipts and expenditure is herewith appended.

4. The audit was conducted by District Inspectors Messrs. T.N.Iniyan Mudaliyar and R.V.Rajagopala Ayyar in accordance with the rules on the subject, and a note on the defects discovered during it has been forwarded to the Chairman. The general result is satisfactory.

5. The amount actually contributed to the Elementary Education Fund from the General Funds of the Municipality was Rupees.
