Sir.

I have the honour to submit herewith an application for exemption from Examination rules on behalf of Mrs. Sellathai Harvey, permanent Assistant, Municipal (late Government) Girls' School, "umbakonam, and officiating Assistant, Government Training School for Muhammadian Women, Trichinopoly.

2. The teacher was exempted by Government in G.O. No. 143 Law (Education) dated 15-7-21 and permitted to draw Rs. 30 plus 10 temporary addition to pay. The exemption granted

granted expired by 14th August 1922. According to the scheme sanctioned in G.O. No. 737 Law (Education) dated 29-5-23 all posts of Assistants in the Government Training School for Muhammadan Women, Trichinopoly, are included in the cadre of Secondary grade teachers carrying a pay of Rs.45-3-90 with a Selection Grade on Rs.100/-. Mrs. Sellathai Harvey continued to do duty in the Government Training School for Muhammadan Women, Trichinopoly, till 31-5-24 when she was reverted to her substantive appointment in the Government (now Municipal) Girls' School, Kumbakonam. During the period, she was in the Government Training School for Muhammadan Women, Trichinopoly, she has drawn pay at Rs.40 (30 plus 10 temporary addition) from 15-8-22 to 30-4-24 and at Rs.29 in the scale of Rs.27½-1½-50 sanctioned for Higher Elementary Grade teachers from 1-5-24 to 31-5-24. But under rule 35 of the Fundamental Rules, the local Government alone has power to fix the pay of an officer at an amount less than the sanctioned pay of the post. I therefore request that you will be so good as to accord the necessary sanction for the pay drawn by the teacher from 15-8-22 to 31-5-24 under Fundamental Rule 35 and to exempt the teacher for the period from Article 1 of the Public Service Notification and from holding a Trained Teacher's Certificate of the Secondary Grade.
