Report on the audit of the Elementary Education Fund Accounts of the Tiruvalur Municipality for the year ending 31st March 1924 by Mr.J.M.Hooper, Examiner of Local Fund Accounts, Madras.

The audit of the accounts for the period from 1st April 1923 to 30th September 1923 was commenced on 17th March 1924 and ended on 26th March 1924 and that of the accounts for the period from 1st October 1923 to 31st March 1924 was commenced on 8th July 1924 and ended on 16th July 1924.

2. During the period under audit, the office of Chairman was held by M.R.Ry.Bava C.Gopalaswami Mudaliyar Avargal.

3. The receipts and expenditure of the fund during the year under report together with the opening and closing balances are shown in the statement of receipts and charges appended.
