Report on the audit of the Elementary Education accounts of the Namakkal Taluk Board, Salem District, by Mr.J.M.Hooper, Examiner of Local Fund Accounts, for the period extending from 1st April 1923 to 31st March 1924.

The audit which commenced on the 16th October and ended on the 22nd October 1924 was conducted by District Inspector Mr.M.Ghaffar Khan Sahib B.A. in accordance with the rules on the subject.

2. During the period under audit, the office of President, Taluk Board, was held by M.R.Ry.P.Singaya Gounder Avargal.

3. A statement of receipts and charges is herewith appended.

4. A note on the defects found in the accounts has been forwarded to the President, Namakkal Taluk Board. The general result is satisfactory.

5. Elementary Education Fund. No separate banking account has yet been opened in respect of the Elementary Education Fund as contemplated in Government Order No.978, Law (Education), dated 16th June 1924.

6. Contribution from the General Account. The Board's contribution from its general revenues for 1923-24 was fixed at Rs.23,920 in sub-paragraph (7) of Government Order No.2086, L & M., dated 21st September 1923. But the actual contribution by the Board as shown in its statement for March 1924 (final) was only Rupees. 11,791-10-11, in spite of the orders issued by Government in Memorandum No.24343, L & M., dated 1st October 1924 that the Board should raise its contribution to Rs.22,500.

7. Inordinate delays by village officers were noticed in remitting into the treasury school fee collections handed over to them by school masters. This should have been detected and adequate steps taken by the President had the school fee collection statements received in the President's office under Rule 148 of the Local Boards Manual been properly checked.

Para. 5 5 Elementary Education Fund:-

The Treasury Deputy Collector, Salem was requested in this office letter O.I.No.Cur.1600/N.T.B. of 1924 to issue necessary instructions to keep separate Banking account in the Sub Treasury in respect of "Elementary Education Fund" from 1st November 24. He has replied that he has made a reference to the Accountant General in the matter and his further reply is awaited.

Para. 6. Contribution from the General Account:-

The Government of Madras have been requested to reduce the Board's contribution towards "Elementary Education" from Rs.22,500 to Rs.15,000 in the circumstances reported in this office letter No.1250/N.T.B. of 1924 dated 9-11-24. ~~The~~ final orders are awaited in the matter.

Para. 7. Inordinate delays &c., by village officers.

Steps have already been taken in the matter.

The D.C.B. statement of school fees received from the Head Master of Elementary Schools are being checked as per instructions laid down in Rule 148 of the Local Boards Manual.

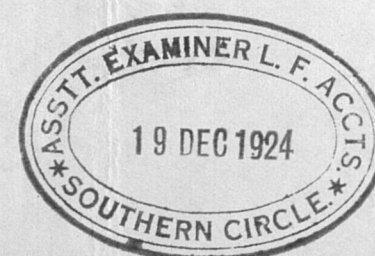
