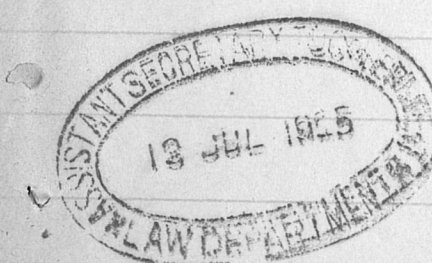
Subject: Requesting Govt to take early steps to found a University at Madras.

The Madras University Act, 1923 provides for the consideration by the University of the question of establishing new University Centres & the submission to Govt of a report thereon at the end of five years after the passing of the Act. The Govt have already in hand the question of establishing a University for the Telugu Districts. They do not contemplate any scheme of establishing a University for the Southern Districts of the Presidency immediately.
