In G.O.No.1016 Law (Education) dated 23-7-23, Government while ordering the abolition of the two posts of peons sanctioned for the Deputy Directress stated that they may be re-employed when the post of Deputy Directress is filled up. Now that a Deputy Directress has been appointed (G.O.No.952 Law (Education) dated 6-6-25) will you please let me know whether with reference to the former G.O. two peons on Rs.15 in the scale of Rs.15-20 may be re-employed up to 23-2-26 on a temporary basis without further reference to Government. The extra expenditure on this account may be met from the anticipated savings under 'Direction- Pay of Establishment- Voted'. I may also mention in this connection that the menial establishment of this office has still further been reduced by the abolition of two posts of peons - vide G.O.No.1444 Law (Education) dated 10-9-24.
