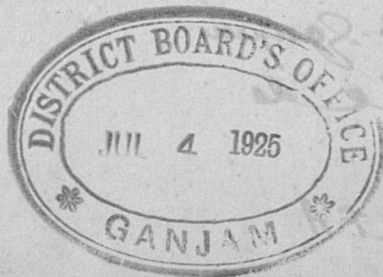

With reference to C.O. No. 953 I.E. dated 8-6-25 I have the honour to state that my Vice President doubts if payment relating to expenditure on repairs and original works of school buildings and petty supervision charges relating to Ministries who supervised school building works be considered "on elementary education within the meaning of section 33 of Elementary Education Act and whether in view of the interpretation put upon the said section by the Advocate General as appearing in C.O. referred to above - such expenditure would not be deemed as expenditure in connection with Elementary Education so as to exclude it due being a charge on Elementary Education Fund.
