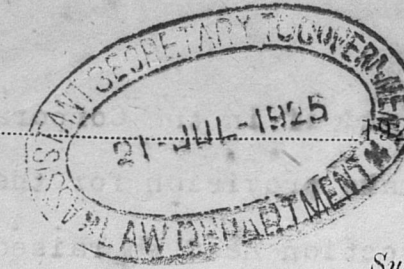

With reference to Government Memo No.1792 A-1 dated 28-5- 25 I have the honour to state that in the fourth edition of the Madras Educational Rules there was provision for the issue of transfer certificates in the case of Elementary Schools but this provision was omitted in the fifth edition as it was desired to make the rules relating to elementary education as simple as was practicable and to avoid any possible restriction as regards the spread of elementary education and the admission of pupils into elementary schools. The issue of transfer certificates, however, is not expressly prohibited
