I have the honour to request that you will be so good as to obtain the sanction of Government for the inclusion in the approved list of the enclosed application for a grant-in-aid towards the purchase of books required for the Bishop Haber College, Trichinopoly, at an estimated cost of Rs. 61.50 only, rendering the institution eligible for a grant of one half of the actual cost not exceeding Rs. 30.75 if and when funds become available, provided that the conditions of the grant-in-aid code are complied with.

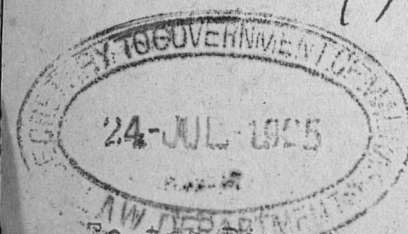

The Government sanction the inclusion, in the approved list maintained in pursuance of G.O.No. 388, Law (Education) dated 14-3-1924, of the application from the correspondent of the Bishop Heber college, Trichinopoly,

For a grant-in-aid towards the purchase of ~~articles of science equipment~~ ^{books required for the college} at an estimated cost of Rs. 6,150. While this approval does not convey any guarantee of grant, it will render the institution eligible for a grant of ~~one-half~~ ^{half} of the cost, not exceeding Rs. 3,075, if and when funds become available, provided that all the conditions prescribed in the Grant-in-aid Code are duly complied with.
