2. The credits taken under 'Education Tax' in the actuals of 1923-24 and for the Government contribution under section 37 in the Revised estimate for 1924-25 should be both raised to Rs 9613 with reference to G.O.No. 309 Mis.Law (Education) dated 3rd March 1925.

3. The sum of Rs 42730 taken credit for in the budget estimate for 1925-26 as Government grants under section 37, is subject to subsequent adjustment with reference to the savings, if any, out of the subsidy paid in G.O.No. 1598, Law (Education) dated 16th October 1924.

4. The Board's contribution from its general revenues in the revised estimate for 1924-25 should be raised to Rs 4680/- with reference to the budget approved in G.O.No. 1378 Mis.Law (Education), dated 26th August 1924 and also to G.O.No. 911 Mis. L & M dated 18th March 1925. The sum of Rs 5720 taken credit for as the board's contribution in the budget estimate for 1925-26 may be accepted with reference to the orders contained in G.O.No. 911 L & M Mis., dated 18th March 1925.

5. The sum of Rs 3000/- taken credit for in the revised estimate for 1924-25 as 'Government grants' under capital represents the amount paid for the equipment of new schools in G.O.No. 1598, Law (Education) dated 16th October 1924. On the debit side of the budget under capital the board has shown Rs 2376 in the actuals of 1923-24 Rs 5000/- in the revised estimate for 1924-25 and Rs 3000/- in the budget estimate for 1925-26 while the corresponding entry on the credit side under the same item is only Rs 3000/- in the Revised Estimate for 1924-25.

6. The sum of Rs 1400/- entered in the budget estimate for 1925-26 under "Clerks and servants" should be reduced with reference to the actuals of 1923-24.

7. With reference to para 4 of G.O.No. 911 L & M Mis., dated 18th March 1925, the Board has not transmitted the report called for therein. The Board may be directed to transmit the same.
