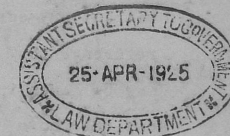

4. It is observed that the Board has not reduced the provision made in 24-25 under "T.A." as per orders contained in sub para (4) of G.O.No. 823 Mis. Law (Edn) dated 20-5-24

5. On the debit side of the budget under the capital the Board has shewn Rs. 1438 in the actuals of 23-24, Rs. 10000 in the R E for 24-25 and in the B E for 25-26 respectively without any corresponding entry on the credit side. With reference to G O No. 2014 Law (Edn) dated 27-12-24 credit may be taken in the B E for 25-26 as "Govt. grants" under capital for a sum of Rs. 5890.

6. In the summary a sum of Rs. 43133 is shown as the opening balance against 'ordinary' but it does not tally with the entries made in the actuals of 23-24 and in the R E for 24-25 but according to the audit report recorded in G.O.No. R. 9 Law (Edn) dated 9-1-25 the opening balance in 24-25 would be Rs. 55952 and the closing balance in that year would be Rs. 43922. Since there would be a large closing balance in 25-26 the Board may be advised to open new schools in scholl-less villages in consultation with the Dt. Edl. Officer and the Dt. Edl. Council.

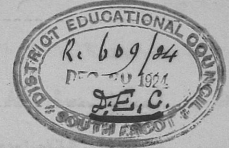
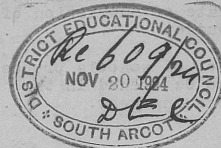
