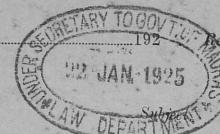

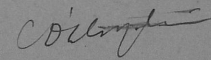

- (a) Re.1-12-0 being the Registration charges met from office Postage stamps for sending teaching grant cheques for 1922-'23 to Correspondents. This amount was actually drawn and recouped in 1923-'24 and so this sum is shown on the Credit side under actuals for 1923-'1924 as unexpended amount of last year's Teaching grants.
- (b) Rs.252-6-0 was the amount of expenditure incurred ~~XXXXX~~ before the amalgamation of the Council Office with that of the Deputy Inspector of schools, Nilgiris Range, and Rs.146/- after the amalgamation, from the Council funds. The circumstances under which the expenditure was incurred after the amalgamation has been explained by the Deputy Inspector of schools, Nilgiris Range in his letter R.C.No.21/24 dated 23-2-'24 in reply to the Director of Public Instruction's letter R.C.No.1655B/22 dated 9-2-'24.
- (c) Rs.355-0-1 is the unspent balance available with the Council to be added to the teaching grant for 1924-'25 as per Orders in G.O. No.1382 Law (Education) dated 26-8-'24. This amount includes the permanent advance with the Council Secretary i.e., Rs.25/-.
- (d) Rs.66-10-7 is the amount of expenditure incurred till the receipt of the Proceedings of the Director of Public Instruction, Madras, R.C.No.837-B/24 dated 17-6-'24.
- (e) Rs.144/-:- Purchase of a duplicator sanctioned in G.O.No.1174 Law (Education) dated 18-7-'24. The expenditure was met from the unexpended amount under Office and Establishment expenses.
- (f) For printing the Combined list of Elementary schools in the Nilgiri District for 1924-'25. This amount was sanctioned in G.O.No.405 Law (Education) dated 15-3-'23.
