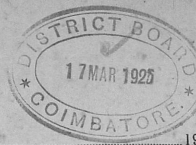

Adverting to Government memorandum No. 3424-A-1 dated 8/9/24, regarding expansion of Elementary Education, this Taluk Board has after full deliberation resolved to levy under section 34 of the Madras Act No. VIII of 20, Education Tax at 3 pias within the area of this Taluk Board from the next fasli i.e. from July 1925. Please see copy of the resolution enclosed.

2. The proceeds of the above taxation for nine months in 1925/26 are estimated to amount to approximately Rs. 7200/- and it is therefore requested that the Government be pleased to kindly sanction a contribution not less than the proceeds of the above taxation under section 37 of the above act. Further ^{as per} decision of the Government contained in para 3 of the memorandum referred to above, I have the honour to request that the Government ^{be also} ~~also~~ be pleased to sanction

subsidies sufficient for opening 25 new schools in the area of this Taluk Board which are of bare necessity. The existing schools under this Board have to be improved urgently, in staff, equipment etc, and these items have been kept pending for want of funds; Several schools are also in urgent need of their own buildings. These expenses are expected to be met from the taxation.
