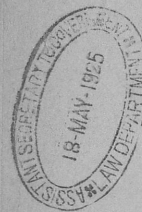

The credit taken for Government contribution under the proviso to section 37 in the revised estimate for 1924-25 should be reduced to Rs 22184 with reference to G.Os Nos. 1121 Law (Education) dated 10th July 1924 and 165, Law (Education) dated 5th February 1925. The credit taken under the same item in the budget estimate for 1925-26 should be fixed at Rs -- 23312 (Rs 22184 plus 1128) inclusive of the subsidy transferred from the Municipal Council, Erode on account of the maintenance of three schools transferred to the Board's management.

3. In the revised estimate for 1924-25 a sum of Rs 1336 should be shown separately as 'contribution received from the Municipal Council, Erode' towards the maintenance of six schools transferred to the Board's management.

4. The entries made in the summary against 'ordinary' do not tally with the total shown in the budget estimate.

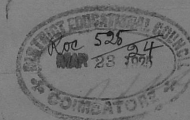

The usual contribution is Rs 15,712/- vide normal budget approved in G.O. no. 2750 A+K dated 3-10-1924. In G.O. no. 1367 Law (Educ) dated 22-8-1924, the board was asked to contribute a sum of Rs 15,712/- for each of the years 1923-24 and 1924-25. The board provides for the following contributions:

Year	Amount
1923-24	Rs 12,896 + 209 under Capital
1924-25	Rs 13,272 + 3,200 under Capital
1925-26	Rs 13,652 + 200 under Capital

The board may be asked to raise the contribution for 1923-24 to Rs 15,712/- including the provision under Capital.

2. The budget results in a deficit of Rs 770%.

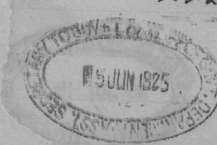
