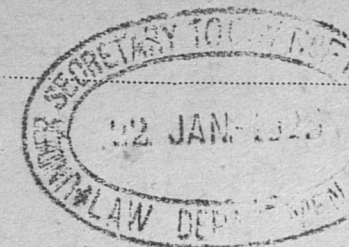

Sir.

I have the honour to invite the attention of Government to paragraph 3 of rule 145 of the Madras Educational Rules(G.O.No.1212 Law(Education) dated 24-7-24) and to request that Government will be pleased to alter that paragraph which reads as follows:

" District Educational Officers shall forward in January of each year to the Commissioner for Government Examinations lists of teachers whose certificates they have completed classifying them as of the first or second class. The Commissioner for Government Examinations shall publish a consolidated list of such teachers in the Fort St.George Gazette"

" District Educational Officers shall publish in the Fort St.George Gazette in March of each

each year lists of teachers whose certificates they have completed classifying them as of the first or second class, and forward two spare copies of these lists to the Commissioner for Government Examinations"

2. The alteration is suggested for the following reasons:- Formerly Inspectors and Inspectresses of Schools used to forward lists of teachers whose certificates they completed, for publication in the Fort St. George Gazette, to the Inspector of European and Training Schools who conducted the final examination till the year 1919- vide G. O. No. 1491 Home (Education) dated 3-12-19. Subsequently when the inspection of training schools was entrusted to the inspecting officers of the department the work of the publication of the lists was done by the Inspecting officers themselves and not by the Commissioner for Government Examinations as laid down in the rule quoted above. The Commissioner for Government Examinations, however, is being furnished with two spare copies of the lists by the inspecting officers concerned.

From the above, it may be seen that the present alteration is suggested merely to regularise a procedure which has been in existence since the transfer of control of training schools referred to above. This modification could not be incorporated in the Madras Educational Rules VI edition when it was under revision, as the change in the procedure was brought to my notice only recently.
