Sir,

With reference to the correspondence ending with G.O.No.1661 Mis., Law (Education) dated 30-10-24, I have the honour to state that the Corporation of Madras has since agreed to take over the management of the 12 Government Muhamedan Elementary Schools in the City on the conditions laid down in Government Memos No.29825-1 L.&M. dated 11-12-23 and No.18624-1 L.&M., dated 18-7-24, and I accordingly recommend the transfer of the schools to the Corporation with effect from 1-9-1925.

With reference to your letter R.O.C.No.144-A/25 dated 6th June 1925, I have the honour to state that the Corporation is agreeable to the transfer of the 12 Government Muhamadan Elementary Schools in the City on the conditions specified in Government Memos Nos.29825 L.E.M., dated 11th December 1923 and 18624-1 L.E.M. dated 18th May 1924 and request you to let me know when the schools will actually be handed over to the management of the Corporation.

3. The Government sanction the pay-
ment to the Corporation of an annual sub-
sidy of Rs. 21,751/- as detailed in the
appendix to these proceedings, being the
average cost of the scales of pay sanc-
tioned for the existing staff and esta-
blishment together with ~~such~~ other
charges of contingent expenditure now
incurred in connection with the main-
tenance of the schools. The rent ^{charges} included
in contingent expenditure will continue
to be paid ^{as subsidies} even if the Corporation pro-

provides its own accommodation for any of the schools now located in rented buildings.

4. The furniture and the library in all the schools, and the buildings constructed by the Govt. for two of the schools will be placed at the disposal of the Corporation, on condition that the Corporation keeps the buildings in good repair and restores ~~the buildings as well~~ as the furniture and library to the Govt., should they cease to be employed for the purpose of imparting education to Muhammadans.

5. As provided in Article 804 of the C.S.R., teachers and other members of the pensionable establishment transferred with the schools to service under the Corporation will continue to render service qualifying for pension from the general revenues.

6. The D.P.I. is requested to submit a ~~re~~ reappropriation statement to meet the amount to be paid to the Corporation of Madras as subsidy ~~under~~ these orders in the current official year.

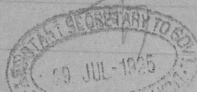

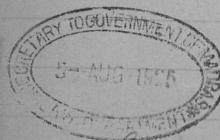

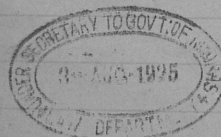
