Report on the audit of the accounts of the Sivakasi Municipality Elementary Education Fund for the year ending 31st March 1925 by Mr. J.M. Hooper, Examiner of Local Fund Accounts, Madras.



The audit of the accounts for the 1st quarter was commenced on 19th September 1924 and ended on 25th September 1924 and the audit of the remaining three quarters was commenced on 1st June 1925 and ended on the 10th June 1925.

2. During the period under audit, the office of Chairman was held by Mr. K. Ramunni Menon, I.C.S. from 1st April 1924 to 29th October 1924 and by M.R. Ry. P. S. Ramaswami Nadar Avargal from 30th October 1924 to 31st March 1925.

3. A statement of receipts and charges is herewith appended.

4. The audit was conducted by District Inspectors, Messrs. N. Gopalakrishna Rao and P. Desikachari, in accordance with the rules on the subject, and a note on the defects discovered during it has been forwarded to the Chairman. The general result is satisfactory.

5. The full amount of contribution from the General account for 1924-25 viz. Rs. 2,380/- fixed in G.O. No. 1160, Law (Education), dated 15th July 1924, has not been credited to the Elementary Education Fund. A sum just sufficient to meet the expenditure viz. Rs. 1,860-13-11 was only transferred from the General account during the year. The balance due to the Elementary Education Fund should now be adjusted.

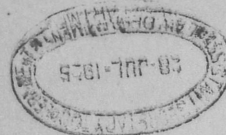

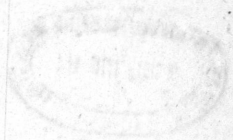
