Sir,

I have the honour to invite the attention of Government to G.O. No. 103 Law (Education) dated 2nd February 1925 and to state that the present monthly establishment charges are Rs. 83-8-0 against Rs. 86-0-0 according to the scale sanctioned by the Government. There is a saving of Rs. 2-8-0 a month. As both the clerks are now drawing Rs. 35/- each and as one of the clerk is getting the same pay for the last four years without any increment, it is proposed to raise the pay of the clerk to Rs. 37-8-0 with effect from 1st April 1925. A copy of the resolution of the District Educational Council, No. 32 dated 11th July 1925, sanctioning the proposal is enclosed. I request that Government will kindly approve of the proposal.
