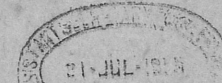

State: Madras. Sir, the question of adjustment of grant was not considered in your report.
Reference your 1810B-2 dated 27th July, I should be glad if say Rs 50,000/- could be given us of the balance of the grant due, as we are incurring considerable expenditure on uncompleted works, and in order to pay it we shall have to take money out of fixed deposit which had been earmarked for other works, and we shall consequently lose interest. The amount due to the school is approximately ~~₹~~ one Lakh of Rupees.

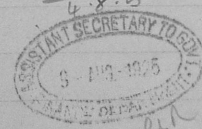

The file dealing with the adjustment of grants due to the school has been sent to the Finance dept. The balance grant due is Rs. 1,13,796 and out of this a sum of Rs. 24,383.12 has to be adjusted in favour of the military dept. The net amount payable to the school is thus about Rs. 89,000. There seems to be no objection to place Rs. 50,000 out of this at the disposal of the committee this can be met from the provision of Rs. 91,800 specifically provided on page 228 of the C.D.E. for 1925-26.

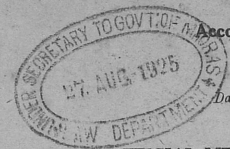
