As regards the date from which the orders in G.O. No. 1243 Law (Education) dated 15-7-1925 are to take effect I may invite attention to my R.O.C. No. 396 A-25 dated 20-7-1925 addressed to Government through the Accountant-General wherein I have suggested that with a view to avoiding complications in accounts the transfer might have effect from 1-8-1925. As regards the records of the schools and necessary information in connection with them, some records have already been transferred to the Inspector-General of Prisons and all will have been sent by the end of this week. The Inspector of European Schools has also been instructed to send to the Inspector-General all records connected with Certified Schools.
