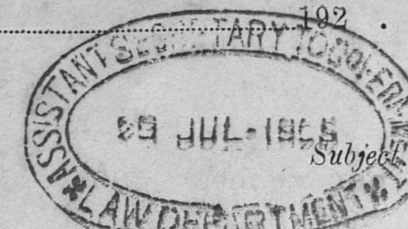

Sir,

I have the honour to state that in G.O.No.Mis. 14 Law(Education)dated 7- 1- 25 Government sanctioned the continuance of the weaving class in the Municipal Elementary School for Devangas, Coimbatore up to 31- 3- 25 and also the payment of a net subsidy of Rs.283 towards the upkeep of the class during 1924-25.

2. The Chairman, Municipal Council, Coimbatore now requests that the class may be continued for another year from 1- 4- 25 and that a subsidy of Rs.560, being one half of the estimated expenditure of Rs.1120 of the class for 1925- 26 as per details noted in the

margin

margin, may be paid to the council.

3. The Adviser

to Government
on Manual and
Vocational
Training who
was consulted
reports that he
inspected the

class on 6-7-25 and that 64 boys from the surrounding Elementary Schools are attending it for 1 hour's instruction per day, and that a trained instructor has been in charge of the class since the 26th June 1925.

The expenses of the class during the current year according to his estimate come to Rs.800 including a sum of Rs.80 for spare shuttles, country, healds, etc as detailed in the margin.

G.O.No.Mis.14 Law(Education) dated 7- 1- 25, is reported to have lapsed and as spare shuttles and spare sets of healds are stated to be urgently needed, the sum of Rs.80 asked for under non-recurring may be admitted.

As regards the recurring charges it will be seen that the trained Instructor joined duty only on 26- 6- 25. Till this date the salary of the Instructor was only Rs.35 per mensem.

Hence the salary for the whole year will be only Rs.466 approximately.

5. Thus the total cost of the class will

Rs.786 only of which Rs.393 being one half will have to be sanctioned as subsidy.

6. But as the municipal council has an unspent balance of Rs.90 standing to its credit at the beginning of the current year, the net amount payable to it during the current year will be Rs.303 which is recommended for sanction, the expenditure being met from the sum of Rs.6300 provided under "31-C(e)(ii) Education-Primary Grants to Local Bodies for Primary Education-Grants for Vocational and pre-vocational training in the budget Estimate for 1925- 26.

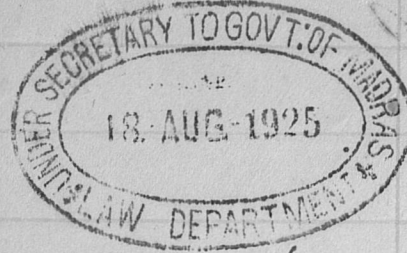
