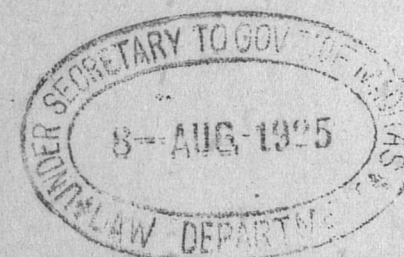

I beg to submit my replies seriatim to the several
remarks made in the budget estimate.

(i) The provision of Rs.6,000/- shown on the debit side
is the sum taken as a loan from the Kaduvayar ferry sink-
ing funds for repairs and reconstruction of the existing
school buildings. The above diversion has been sanctioned

(K) by Government in G.O.No.2469 L & M., dated 6-9-24.

(ii) The entry of Rs.2,000/- shown under "contribution to Nannilam Taluk Board" is evidently an error. It represents the current year's provision for the repayment of the loan of Rs.6,000/- mentioned in para(i) in instalments at Rs.2,000.

(iii) Provision for vocational training:- Detailed proposals will be submitted shortly through the District Educational Officer and the District Educational Council. -- Government may be aware that weaving is taught at Manjakollai a big centre of kaikalars and a similar scheme has been sanctioned at Aliyur, another weaving centre. The balance of allotment that will be available is proposed to be utilized on other items.
