Sir,

Having regard to the high cost of living in the district of Madras when compared with conditions in the mofussil and the fact the Government itself has been obliged to recognise this principle in fixing the minimum salary of the clerical and menial staff employed in the public offices in the Presidency Town, the Madras District Educational Council at the meeting held on the 30th July 1924 unanimously adopted a resolution in the following terms:--

"The Council do recommend to Government that as regards the District of Madras the scale of teaching grants as laid down in Rule 1, Chapter I of the Rules under Sec.42(2) of Madras Act VIII of 1920 be modified

by the substitution of the scale as set forth below--

and that the Government be requested to pass early favourable orders on the subject so as to enable the Council to give effect to the improved rates in disbursing teaching grants for the current year".

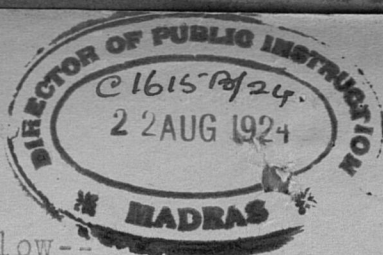

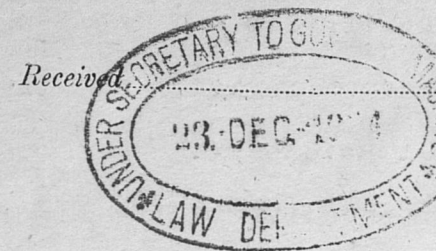

2. The extra cost which the proposal, if accepted, would involve in the current year will be nearly half a lakh.

3. Reference is in this connection invited to para 5 of my letter R.O.C.No.370-B/22 dated 28-5-23 and to G.O.No.955 Law (Education) dated 7-7-23 ^{deferring} ~~declining~~ for Later consideration the revision of the scales of teaching grants even in

respect of localities like the Nilgiris and the Wynad, where there is urgent need for such revision and the extra cost would have been only about Rs.6000/-.

4. If the present recommendation of the District Educational Council, Madras, is accepted, Moffassil Municipalities may ask for similar treatment, especially those where the cost of running aided schools is as high as in Madras. I would further point out that though the whole of the budget provision for the current year under 'teaching grants' viz., Rs.28,75,000 has been distributed, yet the demands of all the District Educational Councils under existing scales have not been fully met.

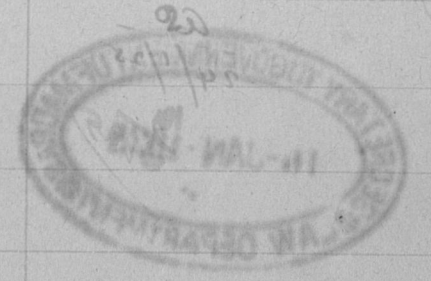

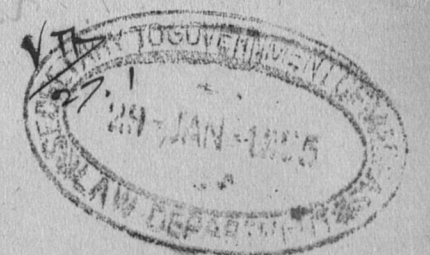
