3. A note on the defects found in the accounts has been forwarded to the Chairman, Municipal Council, Palamcottah. The general result is satisfactory.

4. Against a provision of Rs.6,820 in the Revised Estimates for 1924-25 under "Contribution from the General Fund to the Elementary Education Fund", a sum of Rs.6,358-0-8 only was adjusted to the credit of the latter in 1924-25. The balance should be transferred as early as possible.

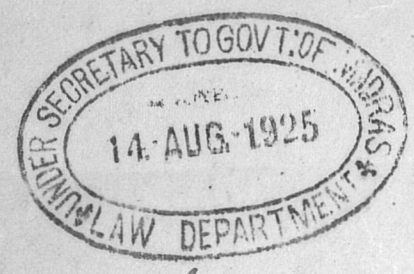
