As the sanction accorded in G.O. No. 1370 Law (Education) dated 25th August 1924 to the retention of the Temporary Assistant on Rs. 93½ employed in the Government College, Kumbakonam, expires on 21st August 1925, I have the honour to request that Government will be pleased to sanction the retention of the post for a further period of one year from the 22nd of August 1925 in the circumstances explained hereunder.

4. The Principal has to do 6 hours teaching work a week besides attending to the normal administrative work of the College, which occupies a large part of his time, and in the interests of efficiency, the continuance of the post is necessary.

5. The necessary budget provision for the charge has been included in the Budget Estimate for 1925-26.

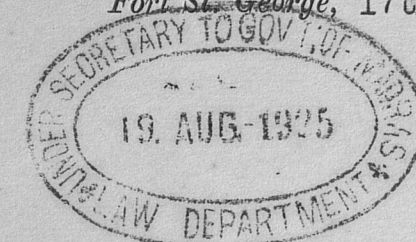
