Sir.

In their order No. 812 Law (Education) dated 11th June 1923, Government approved the Director's proposal to take on lease for a period of three years from 1-4-22 the buildings now occupied by the hostel attached to the Presidency College, Madras, at a rent of Rs.280 per mensem. As the lease in question expired on 31-3-25, I have the honour to request that sanction may be accorded to its renewal for a further period of three years from 1-4-25. The Principal, Presidency College, recommends the renewal of the lease and reports at the same time that the landlord has carried out the necessary repairs to the building

2. The rent recovered from the inmates of the hostel should be credited to Govt. The net liability on provincial funds on account of rent charges

should not exceed Rs 1,352/-

a year.

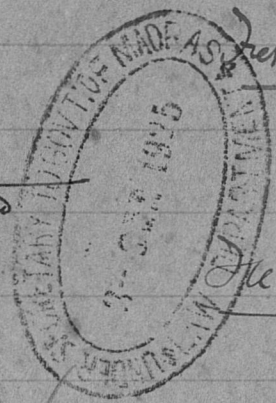
