In the absence of the annexure prescribed in G.O.No.1119 Law (Education) dated 10-7-24 it is not possible to say whether the provision made in the Budget Estimate for 1925-26 is adequate.

3. Entries have been made on the debit side, under 'capital' without any corresponding entry on the credit side.

4. The total of the credits taken in the Budget Estimate for 1925-26 is Rs.45210 and not Rs.53,570 as shown therein.

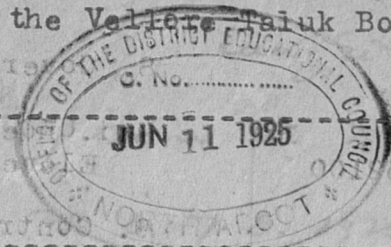

The budget estimate of the Elementary Education fund under the control of the Taluk Board, Vellore, for the year 1925-26 is approved subject to the following remarks:-

(1) The provision made under the 'Salaries of masters' in the Budget Estimate for 1925-26 is less than that shown in the Actuals of 1923-24 and in the Revised Estimate for 1924-25.

In the absence of the assurance prescribed in G.O. No. 1119 (aw

(Education) 2,10.7.24, which the Board has not furnished, it is not possible to ^{verify} whether the provision made in the Budget Estimate for 1925-26 is adequate. This should now be furnished.

(ii) There are no entries on the credit side ^(under Capital) corresponding to entries made on the debit side.

(iii) The total of the credits taken in the Budget Estimate for 1925-26 is Rs. 45,210 and not Rs. 53,570 as shown therein.

(iv) The opening balance on 1.4.25 under 'Ordinary' according to the particulars furnished in the Revised Estimate for 1924-25 is Rs. 1,220 and not Rs. 1,210 as shown in the Summary.

~~12.8.25~~ (v.) If the above alterations are carried out the budget will result in a deficit. The Board should curtail its expenditure to avoid the deficit.
